Ministry of Housing, Town Planning and the City, is launching a limited national and international screening for pre-selection of qualified firms or groups of companies with the capabilities required to support **the study and /or projects completion of integrated sets of four hundred (400) housing units less than two thousand (2000) units with their accompanying facilities across the country.**

Only companies or groups of social firms (National , Foreign or foreign Algerian mixed) with a certificate of professional qualification and classification classified to **category four (04) or more**, or equivalent for foreign companies; and **having realized at least a two-hundred (200) units, one piece**, or accumulating a minimum of four hundred (400) housing or accompanying facilities classified at least in category (C) with a certificate issued by a tenderer's bank that attest his solvency dated less than three (03) months, may withdraw the specifications beside the Ministry of Housing, Town Planning and the City, General Direction of Resources (Markets division) Address: located at 135 Didouche-Mourad Street - Algiers against payment of reproduction costs, set at **2.000,00 DA** non-refundable.

Companies listed on the first "short-list" for studies and / or the completion of integrated sets of 2000 to 5000 housing units, are excluded from the said participation.

Specifications will be withdrawn by the tenderer or his duly designated representative, in the case of a consortium, the specifications must be removed by the proxy or the duly designated representative.

Tenders, accompanied by valid supporting documents are presented as required by Article 12 of the specifications.

Tenders will be contained in a sealed envelope and closed. This envelope will be placed in an anonymous outer envelope, closed and presented as follows :
